# **Application for a framework agreement**

## Vehicle data information products

### A framework agreement is required to obtain:

- fee-based standard data records
- customised data records, evaluations and analyses.

### Notes:

- The requirement for a framework agreement may be waived in the case of one-off requests for anonymised data or factual data.
- All freely accessible data records ('open data') may be obtained without a framework agreement.
- The fee for setting up a framework agreement is set out in the FEDRO Fees Ordinance (as at 01.01.2022: CHF 280).
- Once a framework agreeement is in place, vehicle data information products can be obtained by submitting a request for disclosure of personal data.

### **Procedure**

- Please consider the template for a framework agreement and the description of information products (www.ivz-fahrzeuge.ch).
- 1. If applicable, complete this application form and email it to: fahrzeugdaten.analyse@astra.admin.ch.
- 2. FEDRO will assess your application and draw up a framework agreement.
- 3. FEDRO then sends out
  - (a) by post, two signed agreements to the delivery address indicated; and
  - (b) by email, the invoice for setting up the account.
- The applicant returns a countersigned copy of the agreement to the FEDRO by post. Federal Roads Office (FEDRO)


